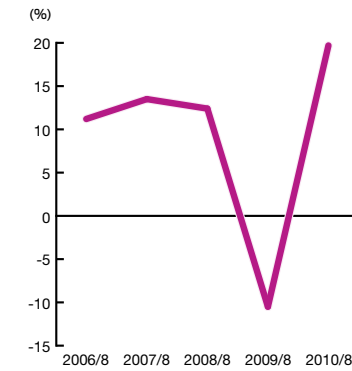
売上高 / 増収率

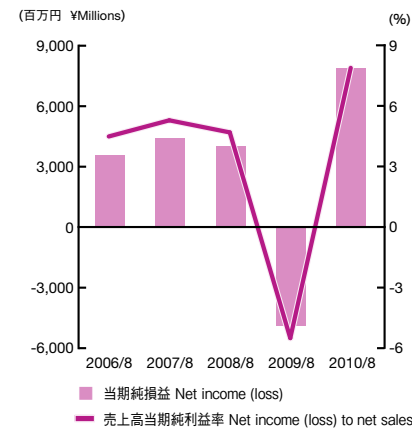

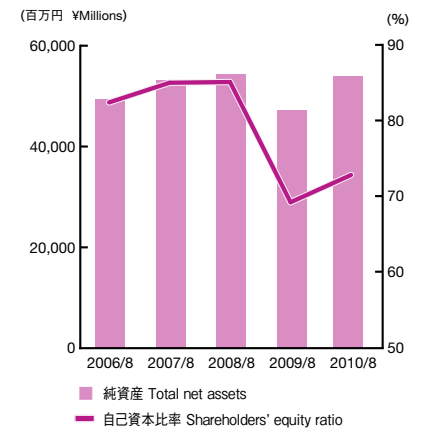

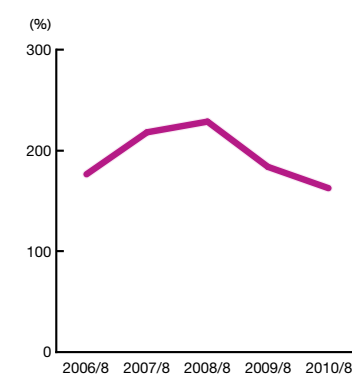

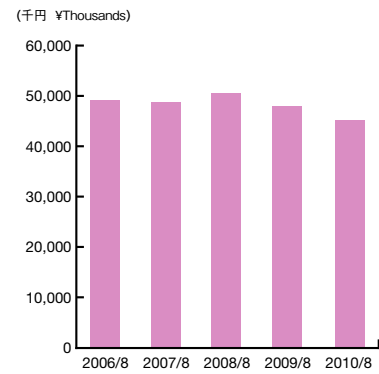

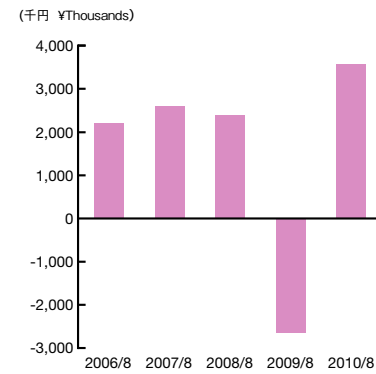
